1. Chairperson's Report 2016:

2016 was a year of solid progress in Wexford RSASS during which our staff continued to provide support to those who experienced the trauma of sexual abuse either recently or in the past. The statistics published in this report show that the demand for our services continues to grow and in the autumn of 2016 there was a waiting list for our services for the first time in many years. The counsellors were, however, able to manage this, so that the waiting list and time were reduced quickly.

Our Centre, one of sixteen in Ireland, is supported by core funding from TUSLA who took over responsibility for the management of this sector, at national level, in 2015. During 2016, the second year of TUSLA's management of our sector at national level, we benefited from an operating environment where lines of responsibility were clearer, where the focus on the development of the RCCs and where responses to fresh initiatives were generally positive.

The year was notable for a number of features:

- The continuing increase in the demand for our services (this is described in full in the Centre Manager's report)
- The further development of our services as we seek to implement clinical best practice including the introduction of a new model of clinical supervision
- Our participation in the Manuela Riedo programme, funded by the EU, which entails the introduction of a new programme in schools

The Centre faces a number of challenges in the short-term:

- In preparation for the introduction of commissioning, TUSLA has begun a sectoral needs analysis. This will be undertaken in Wexford in 2018.
- We are outgrowing our current premises and need to find space to accommodate better counselling facilities and an additional member of staff when the Manuela Riedo programme begins.
- Definition of a strategic direction for the organisation (A facilitated review undertaken by the board and the staff in April 2017 proved productive in identifying potential strategic options.)

The members of the board will continue to support the Centre manager and staff by ensuring that the necessary resources are available to operate the services.

On behalf of the board I would like to thank Clare Williams, the Centre Manager. Clare continues to manage the day to day operation of the Centre most effectively, while also strengthening our links within the sector with other RCCs and TUSLA. I would also like to thank our team of counsellors who work with great dedication and professionalism to ensure that the needs of our clients are met.

Finally I would like to thank my fellow directors whose astute guidance and generous commitment to the development of the Centre have proved invaluable.

This is my last AGM as chairperson. I have greatly enjoyed my time as a member of the board, particularly the last four years. As I leave I am delighted to know that the Centre is well placed to meet the needs of our growing cohort of clients thanks to the dedication of Clare Williams, the team of counsellors and the board. I wish the Centre continued success.


2. Manager's Report 2016:

The Wexford Rape & Sexual Abuse Support Service (WR&SASS) has seen a dramatic increase in referrals year by almost 50% from 2013-2016. More and more clients are presenting to our service to seek support for the trauma they endured, mostly as children. Clients who have the courage and bravery to contact the centre are usually faced with a complexity of issues to address. Many present with depression, anxiety, feelings of guilt and shame. As well as these feelings there can be a very complicated family story that comes with the childhood sexual abuse. It can take a long period of time to 'untangle' these issues and work to find a way to accept what has happened but yet move forward with their lives.

In the WR&SASS the team of counsellors work with and support women, men and young people who have been affected by sexual violence. They have an in-depth understanding of trauma and the effects it can have on the child as well as the grown adult dealing with past abuse. It is through this expertise as well as through the therapeutic relationship that the client is empowered to work through their issues and find the tools to cope on a day to day basis.

2016 saw the introduction of a new model of clinical supervision. All our counsellors now receive group and one to one supervision by the same supervisor. This ensures consistency of practice. There is also a formal place within the supervision model for the role of Manager. There is regular and appropriate communication between the Clinical Supervisor and Manager in relation to organisational matters including quality of the work, consistency of practice, development of policies and procedures and training needs. This has worked extremely well and has seen rapid and effective developments to the organisation.

One to one counselling is the core of the work of the centre. In 2016, the team have been actively reviewing and developing our model of counselling as well as our policies and procedures to ensure the best possible service is delivered to our clients. The work on this model continues into 2017.

The service was delighted to be part of a pilot education programme for the Manuela Riedo Foundation. We were 1 of 3 centres nationally who delivered the programme to a group of young people. The aim of the programme was to educate young people in order to minimise sexual violence, convey what consent is and what constitutes a healthy relationship. 2017 will see further developments with this programme.

I would like to thank the counselling team for all their hard work, commitment and positivity in relation to the development of the centre in 2016. I would also like to thank Freda Quinn, our volunteer who is always willing and able to help and support in any way she can.

I would also like to thank the board of management for their on-going commitment, support and enthusiasm. In particular, I would like to thank Mary Gallagher who has been pivotal to the development of the centre over the past 13 years. She has lead the organisation in the position of Chairperson for over 6 years. We are indebted to her for her wealth of support and guidance. I would like to thank her most sincerely for sharing her skills, knowledge and expertise as she resigns from the board this year.

3. Mission Statement, History & Service Provision

Mission Statement:

Our mission is to provide a counselling service sensitive to the needs of survivors of Sexual Violence, Rape, Childhood Sexual Abuse and Sexual Harassment, that is empowering, non-judgmental and consistent in approach, that promotes the safety, privacy and dignity of the survivor.

Key principles which underpin the development of our service:

Violence & Sexual Abuse in relationships must always be viewed as an abuse of Human Rights. They must not be rationalised or minimised and there must never be an acceptable or tolerable level of violence. Anyone can be a victim of sexual violence, irrespective of age, race, income or employment status.

History:

The Wexford Rape & Sexual Abuse Support Service was established in 1995 as an indirect result of the Kilkenny Incest Investigation and the need for a free counselling service in the Co Wexford area. It quickly expanded as more and more survivors sought counselling.

The WR&SASS provides services to victims of sexual violence, as well as to those who support them e.g. families and friends. We provide a service to women, men and teenagers 14 years and up. We cover the geographical area of County Wexford offering our services in Wexford town, Gorey, Enniscorthy and New Ross.

The centre provided the following services in 2016:

- Telephone helpline
- Counselling and psychotherapy
- Court Accompaniment
- Garda Accompaniment
- Advocacy and Referral
- Preparation of Victim Impact Reports
- Crisis Support

The main aim of the centre is to work towards the elimination of sexual violence in our society. As such the centre is involved in working in a collaborative manner with relevant agencies to achieve this aim. In 2016, the centre worked with a wide range of agencies and networks from both the community/voluntary sector as well as with statutory bodies.

The Centre worked with the following in 2016:

- Children and Young People's Services committee (CYPSC) and CYPSC Young People and Mental Health Working Group

4. Core Statistics - Counselling Service:

In 2016, the team supported a total of **140** individuals in our counselling service.

Of the 140, there were **47** who carried over from **2015** and there were **93 new** referrals in **2016**.

Of the 93 new referrals:

> 78 were female and 15 were male.

Of the 93 new referrals:

- > 62 were from Wexford
- > 14 were from Gorev
- > 13 were from Enniscorthy
- > 4 were from New Ross.

Out of the 93 new referrals, 8 of the referrals were minors. In 2017 the service worked with a total of 10 minors through our counselling service.

There was a total of **1,414** sessions of one to one counselling delivered in 2016. There were, on average **50** clients weekly attending for counselling during 2016.


There were **2** clients who were accompanied to An Garda Siochana and **6** individuals who were accompanied to their respective court cases, each of different length.

In 2016, the Team completed training including:


- Clinical responses to Complex Trauma (Felicity Kennedy),






GENDER OF CLIENT









WHEN ABUSE WAS PERPETRATED








COMPLAINTS FILED BY SURVIVORS







8. Client Story

I am a 54 year old woman. My childhood years were taken away from me because I was abused and raped by my step-farther. I lived in fear every single day. The extent of the trauma that I experienced became very real for me when I started counselling with the Wexford Rape & Sexual Abuse Support Service (WR&SASS).

I learned to overcome that terrible fear by talking about it in counselling. It has brought me through the most horrific times and it helped me take back my power and be able to face my abuser in court. I am not afraid of him anymore. For that I am very proud of and hold my head high.

My counsellor gave me the chance to safely talk about what I went through and having that one hour a week allowed me to gradually get the horrific abuse and the shame that I carried for so long out of my head. Sometimes it was so upsetting that I didn't think I could get through it. But now looking back I can see how important the counselling was in helping me become stronger, happier and a more confident person.
